PAYMENT/REFUND INFORMATION

- * The cost of each class is determined by class length. Classes listed separately on the schedule cannot be combined for price-breaks or discounts unless posted as a promotional cost.
- * Classes for 2 and 3 package deals can only be combined with back to back classes or classes held on the same day.
- * Enrollment in classes is a financial responsibility for an entire trimester.
- * NO REFUNDS ON CLASSES
- * Classes not attended must be paid for, however, can be made up within the same registration period.
- * Discounts are given only if tuition is paid at the beginning of each pay period.

FINANCE CHARGE

Overdue accounts are subject to a finance charge of 1.5% per month (18% per annum) These charges will appear on your statement and are due and payable.

NSF POLICY

There will be a \$30.00 fee charged for any returned checks that are received by Shirley Van's Dance Studio.
